JUDGING CRITERIA:

1. A high level of leadership

3. A desire to excel
4. An understanding of construction principles and theory
5. A high skill level, developed through education and job experience
6. The experience, discipline and focus to bring thoughtfulness and skill together successfully in various types of construction projects.
7. An adherence to fair and responsible business practices.

NOMINATION RULES:

1. All nominations must be received by Friday, July 13, 2007
2. All award nominees will be announced prior to the event
3. You may **not** nominate your own firm.
4. You may nominate one individual for each award category
5. You may nominate an employee in the Supervisor of the Year category
6. Nominees do not have to be members of the AGC in order to qualify, however some preference may be given to a nominee representing an AGC Member firm.
7. In 100 words or less for each nominee - describe why you believe your nominee(s) deserves the award.
8. Each nominee will be informed of their nomination and interviewed by a four-member judge's panel that will follow an established set of questions.
9. Each nominee will be apprised of the criteria and be asked to give three personal references, which in turn will be contacted for their comments regarding the nominee.
