



## Field Engineer

### **Key Responsibilities**

- Assist in processing submittals and RFIs (Requests for Information)
- Coordinate with survey crews for layout and verification of work
- Work with the project team to prepare field work packages for upcoming activities

#### *Project Support*

- Work closely with Project Managers, foremen, and subcontractors to facilitate smooth field operations
- Coordinate material deliveries and verify materials meet specifications
- Assist with procurement activities and equipment coordination
- Participate in progress meetings and communicate field conditions to the project team
- Support the Project Manager with administrative tasks as needed

#### *Safety & Compliance*

- Participate in daily safety briefings and site safety inspections
- Help enforce safety policies and procedures on the jobsite
- Ensure compliance with OSHA regulations and State agency requirements

- Bachelor's degree in Civil Engineering, Construction Management, or related field preferred; relevant work experience in heavy civil/infrastructure construction will be considered
- 0-3 years of experience in civil construction, preferably in roadway or bridge construction
- Experience with Connecticut Department of Transportation projects

- Ability to read and interpret construction drawings, specifications, and contract documents
